Actions Initiated Based on Feedback

Students' Feedback

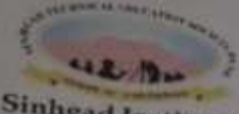
1. **Increased Use of Presentations and Practical Teaching Methods:**
 - Presentation-based evaluations were integrated into multiple subjects.
2. **Enhancing Placement-Related Activities:**
 - Rubicon training and TCSion certifications were introduced to boost placement opportunities.
3. **Developing an Industry-Oriented Syllabus:**
 - Certification programs like Financial Modeling, Advanced Competency Mapping, and PMP were added.
 - Guest lectures by industry professionals were organized.
4. **Introducing More Projects and Practical Assignments:**
 - Group projects, fieldwork, and model-based assignments were incorporated into courses such as Business Research Methods and Economic Analysis for Business Decisions.

Alumni Feedback

1. **Expanding Certification Opportunities:**
 - Additional certifications like TCSion, Rubicon training, financial modeling and Advanced Competency Mapping were offered.
2. **Providing Career Guidance:**
 - Competency Mapping processes for first-year MBA students were implemented to help identify skill gaps and inform specialization decisions.

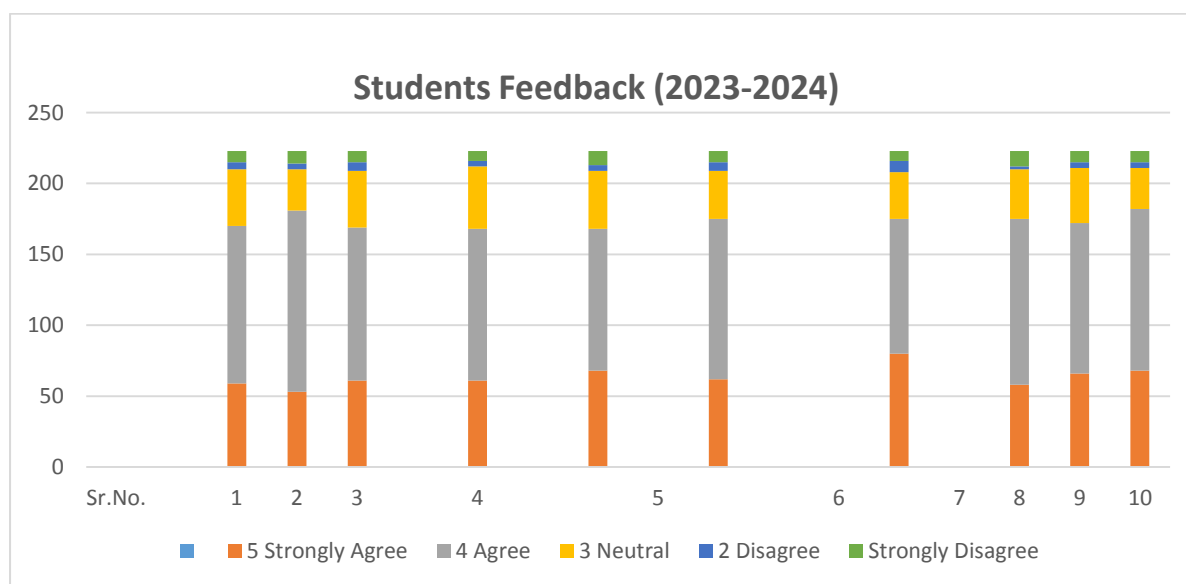

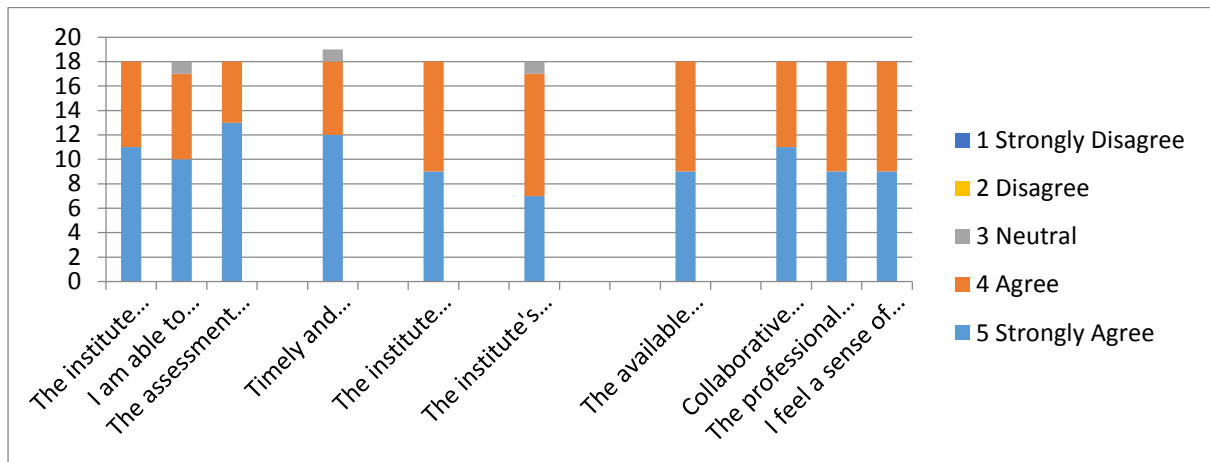

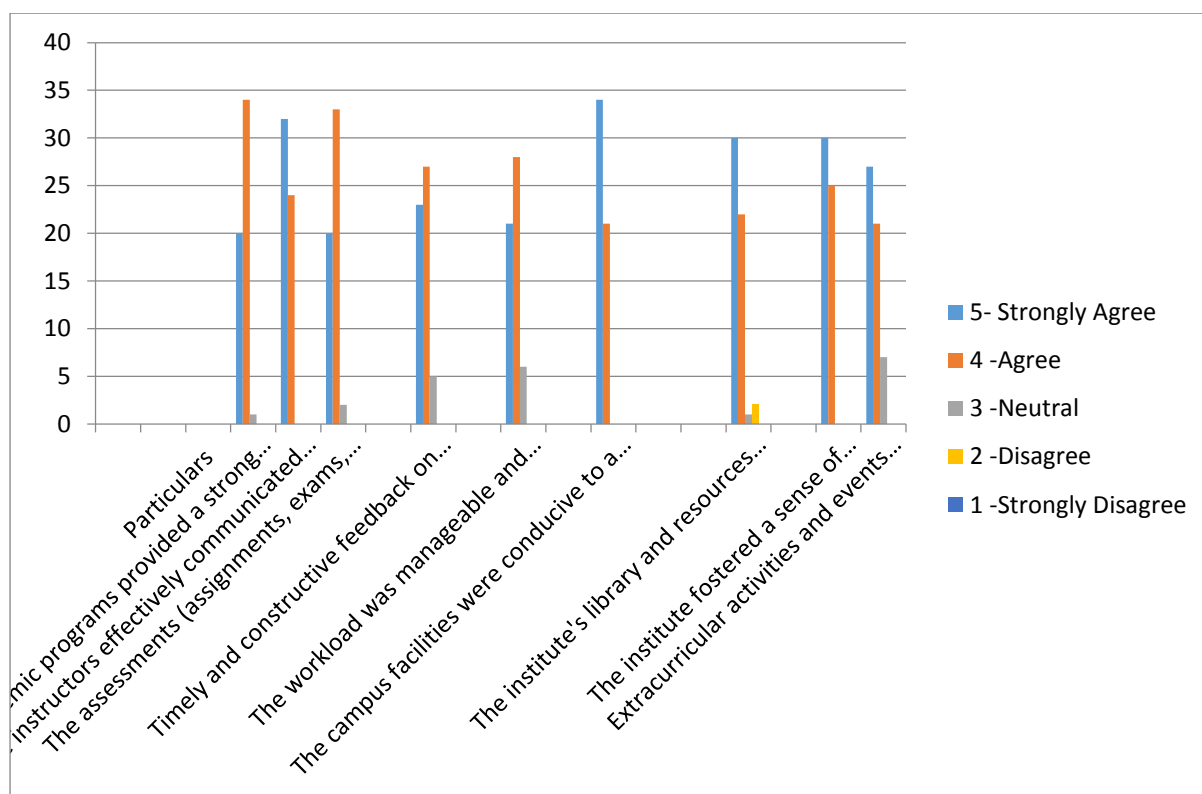
